Draft of July 20, 2023 Meeting

Action Items:

- Director Lynn Fegley reminded the commission of its importance and the role they serve: Public input process is key. You carry the charge of bringing the perspectives with you of the people you represent.
- The department will be science and data driven in guiding our decision making. We have many different ways to manage our species, including the importance of the commission's input from around the state.
- The Fishing and Boating Service is down-staffed, we have a lot to do to get our house in order. Getting up to speed is a priority of the director in order to better serve the public.
- Another key priority is addressing invasive species. The department is in the process of recruiting a new biologist to focus solely on invasive fishes.

- The director encourages the commissioners to review our website, specifically our programs which are found under the Programs Tab.
- Paul Genovese will share Director Fegley's contact information with all commissioners in an effort to stay transparent and please reach out anytime.
- If you see any violations or concerns while on the water, the NRP encourages you to call/text message 443-433-4112. You can also email to mwc.dnr@maryland.gov.
- The department stresses the importance of commercial reporting, the department encourages commissioners to remind folks to report and the importance of it.
- The department plans to have commercial reporting updates be a regular component of the commission agenda moving forward.
- The department uses reporting data to manage better and to solve problems, please report as accurately as possible.
- Commissioner Scerbo voiced some concerns regarding the commercial reporting hotline, the department acknowledges it is not perfect and will work to improve. Regarding reporting options, the department would like to work towards moving past the FAX option, other options are available, contact Carrie Kennedy if you are interested.
- The department requests comment from the commission on fisheries-related items it is currently proposing and scoping. Please review your handouts and send your comments to Sarah Widman (sarah.widman@maryland.gov) or Jacob Holtz (jacob.holtz@maryland.gov). Additionally, the items reviewed during the meeting will be posted on the department website, beginning a 15 day public comment period on these items at that time, please share with your constituents.
- Link to the document Mike and Lynn referenced regarding the Atlantic States Fisheries Commissions striped bass board, including the August meeting agenda and draft addendum II (page 85 of the full document) http://asmfc.org/files/2023SummerMeeting/AtlStripedBassBoard_August2023.pdf. During the August ASMFC meeting there will be a vote on the draft.
 - This commission and the public will have the opportunity to comment during the comment period that should open between August-October, on the approved options within Addendum II. Conservation equivalent options will not be available.
- The commission advises the department to wait on taking any action on the idea of proposing restrictions on haul seines on the Chicamuxen Creek until further evidence is gathered (see if this is more than a single incident).
- Additional Business topics brought up (not on agenda/no voting).
 - Commissioner Scerbo discussed recreational/charter fishing out of pounds net has become a larger problem and wants to let the NRP know.
 - NRP reminds folks to call in violations when observed, 443-433-4112.
 - Commissioner Sieling's proxy Jack Brooks wants to make everyone aware of the cheap imported crab
 meat coming into the state, which has led to extremely low dockside prices. Local picking houses have
 slowed work due to pricing.
 - Commissioner Gwin informed the commission that State Senator Carozza has an open invite to DNR leadership to attend a boat ride to see and discuss ongoing shoaling issues near the Ocean City inlet.
 - Lynn Fegley will inform the correct staff and send them Sonny's contact info.
 - Vice-Chair Gilmer will attempt to set up another blue catfish meeting to discuss alternate ways to catch the fish, including watermen. He will inform the commission and Paul when a meeting is set up.
 - Commissioner Brown commented that the reference points/target for striped bass are too high and should be addressed/lowered.

Public comment - Bill Paulshott and Allison Colden commented that the MDA will have a listening session
to discuss federal funding and how it can be dispersed, it has to do with food resiliency and blue catfish
could be incorporated. Paul Genovese will share the listening session information with the commissioners
(once Allison forwards to Paul).
